**Subject:** Recognition certificate for the school under Sub-rule (4) of Rule 11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam,

With reference to your application and subsequent correspondence with the school/ inspection in this regard, I convey the grant for provisional recognition to **Golden Era School, Village Dittupur Jattan, Tehsil Nabha, Distt. Patiala (Punjab)**, for classes 1<sup>st</sup> to 8<sup>th</sup> Std. from 01.04.2019 to 31.03.2022.

The above sanction is subject to fulfillment of the following conditions:

1. This grant does not in any way imply any obligation to recognize/ affiliate beyond class 8<sup>th</sup> Std.
2. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2009 (Annexure II).
3. The school shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide Free and Compulsory Elementary Education till its completion. Provided, further that in case of pre-primary classes also, this norm shall be followed.
4. For the children referred in paragraph 3, the school shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements, school shall provide a separate bank account.
5. The School/ Society shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The school shall not deny admission to any child –
  - For lack of age proof,
  - If such admission is sought subsequent to the extended provided prescribed for admission
  - On ground of religion, caste or race, place of birth or any of them.
7. The school shall ensure:
  - i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
  - ii) No child shall be subjected to physical punishment or mental harassment.
  - iii) No child is required to pass any board examination till the completion of elementary education.
  - iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 21 of the Act.
  - v) To include child of special needs as per provisions of the Act.

- vi) The teachers are recruited with minimum qualifications as laid down under Section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act, do not possess minimum qualifications shall acquire such minimum qualifications within five years.
- vii) The teacher performs its duties specified under Section 24(1) of the Act and;
- viii) The teachers shall not engage himself or herself for private teaching activities. The school shall follow the syllabus on the basis of curriculum laid down by the appropriate authority.
- ix) The admissions shall be done keeping in view equality in distribution of facilities as specified in Section 19 of the Act.
- x) The school shall maintain the standards and norms of the school as specified in Section 19 of the Act.

- xiii) The school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force;

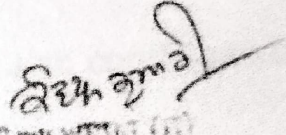

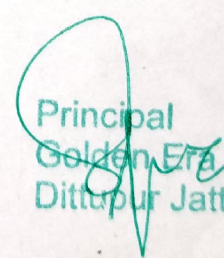
### **ANNEXURE-3**
